## Entry Form Criteria for 2012 Random Selection Drawing for Issuance of Series 6, 7 and 9 Liquor Licenses

- I. Drawing entry forms and applications will be accepted at the Arizona Department of Liquor Licenses and Control (DLLC) Licensing Division beginning at 8:00 a.m. Thursday, April 5 and ending at 3:00 p.m. Wednesday, May 2, 2012. Entries submitted after 3:00 p.m. Wednesday, May 2, 2012 will NOT be accepted. All entry forms must be received, accepted and date-stamped by the department prior to 3:00pm Wednesday, May 2, 2012. A completed application packet and fees must accompany each entry form. Two separate checks are required; a \$100 non-refundable application fee and a fingerprint fee. For your fingerprints, you have the option to pay DLLC \$35 to have your fingerprints taken when you submit your application (\$13 + \$22 DPS fee), or pay only the \$22 DPS fee when a completed fingerprint card from an bona fide fingerprint service accompanies your application. The \$100 non-refundable application fee shall be paid by money order, cash or cashier's check. Checks returned to the department for insufficient funds will automatically disqualify the entry. If you do not enter successfully, only the \$22 DPS fingerprint fee will be returned to you.
- II.
  - a. Entry forms and applications will be accepted by mail or in person at the DLLC offices located in the Industrial Commission of Arizona Building, 800 W. Washington, 5<sup>th</sup>Floor, Phoenix, Arizona 85007.
  - b. All entry forms and applications shall be printed in black ink or typewritten.
  - c. Any illegible or incomplete entry forms will be considered invalid and returned.
- III. Licenses available for the 2010 drawing are listed on the DLLC web site, [www.azliquor.gov](http://www.azliquor.gov), and at the DLLC offices located in the Industrial Commission of Arizona Building, 800 W. Washington, 5<sup>th</sup>Floor, Phoenix, Arizona 85007.
- IV. Random Selection Criteria
  - a. Each applicant will be required to meet the qualifications of licensure under A.R.S. §4-202 and 203 before obtaining the license.
  - b. Pursuant to A.R.S. §4-203, every application for an active liquor license must establish a location to meet license issuance requirements.
  - c. No person shall submit more applications than the number of licenses available for each series in a county. (See the list below)
  - d. No person shall submit more than one entry form per location per liquor license series.
  - e. If the number of applicants for entry into the drawing is less than the number of a license series that may be issued in a county, the department shall issue a number of licenses equal to the number of entries received for that license series in that county.
  - f. An independent accounting firm will assign an ID number to each entry. These numbers will be mailed to applicants by the firm prior to the date of the random selection.
  - g. Alternate applicants will be drawn for each license series in each county if applicable. An alternate list of applicants will be maintained until all new licenses have been issued.
  - h. Alternates shall be eligible for consideration as licensees in the event a successful applicant chooses not to be considered or is disqualified. Such consideration shall be determined by the numerical order in which the alternates were drawn.
- V. Random Selection Drawing. If there are more applicants than the number of licenses available, a random selection drawing will be conducted on Monday, May 14, 2012 at 10:00 a.m. in the auditorium of the Industrial Commission Building located at 800 W. Washington, Phoenix, Arizona 85007. The random selection process will be overseen by an independent accounting firm.
- VI. Names of the successful applicants and alternates will be posted within 24 hours of the lottery drawing on the DLLC website, [www.azliquor.gov](http://www.azliquor.gov), and at the DLLC offices located in the Industrial Commission of Arizona Building, 800 W. Washington, 5<sup>th</sup>Floor, Phoenix, Arizona 85007.
- VII. Upon completion of the Random Selection Drawing, the selected applicants will be notified by U.S. Mail. Liquor license applications for the selected applicants will be distributed to the appropriate local government for immediate posting at the proposed location and for processing. Upon disqualification or withdrawal of an application, an alternate will be notified by phone and U.S. Mail immediately. The completed application for the alternate will be distributed to the appropriate local government for posting and processing.
- VIII. A non-refundable deposit of fifty percent (50%) of the fair market value of the license shall be paid (certified funds only) to DLLC before 3:00pm August 27, 2012. The balance of the fair market value will be due within (5) days after notification that the license is ready for issuance. Failure to submit payment will result in an automatic disqualification. In addition, an original license issuance fee as well as annual renewal and surcharge fees will be calculated and due at the time of issuance. Payment shall be made by personal check, money order or direct deposit. See schedule below for fair market values.
