Entries received after 3:00 p.m. Friday, May 16, 2014 will not be eligible. Answer all questions completely. Submit one form for each proposed location. - I understand that if I am selected, I will be required to pay a non-refundable fifty percent (50%) fair market value deposit to the Department of Liquor before 3:00 p.m. Monday, September 15, 2014. Payments shall be submitted in the form of a certified bank check. Failure to submit the non-refundable fifty percent (50%) deposit before 3:00 p.m. Monday, September 15, 2014 will result in automatic disqualification of the applicant.
- I understand that if I am selected, the balance of the fair market value will be due within five days after notification that the license is ready for issuance or no later than 105 business days after the random selection drawing, whichever date occurs first. Failure to submit required fees will result in disqualification and an alternate applicant will be chosen.

Entry Criteria for 2014 Random Selection Drawing for
Issuance of Series 6, 7 and 9 Liquor Licenses

- I. Drawing entry forms and applications will be accepted at the Arizona Department of Liquor (DLLC) Licensing Division between 8:00 a.m. Monday, April 21, 2014 and 3:00 p.m. Friday, May 16, 2014. Entries submitted after 3:00 p.m. Friday, May 16, 2014 will NOT be accepted. All entry forms must be received, accepted and date-stamped by the department prior to 3:00pm Friday, May 16, 2014. A completed application packet and fees must accompany each entry form. Two separate checks are required; a \$100 non-refundable application fee and a fingerprint fee.
 - a. Fingerprints:
A \$22 DPS background check fee must be paid to the Department of Liquor when submitting a completed fingerprint card from an bona fide fingerprint service accompanies your application. The \$100 non-refundable application fee shall be paid by personal check, money order, cash or cashier's check. Credit cards are not accepted.
Checks returned to the department for insufficient funds will automatically disqualify the entry. If you do not enter successfully, only the \$22 DPS fingerprint fee will be returned to you.
 - b. Fair market value 50% deposit and balance payments:
 - i. Shall be certified funds only.
 - ii. Credit cards are not accepted.
- II. Entry forms and applications:
 - a. will be accepted by mail or in person at the Department of Liquor offices located in the Industrial Commission of Arizona Building, 800 W. Washington, 5thFloor, Phoenix, Arizona 85007.
 - b. shall be printed in black ink or typewritten.
 - c. which are illegible or incomplete will be considered invalid and returned.
- III. Licenses available for the 2014 drawing are listed on the Department of Liquor web site (www.azliquor.gov) and in the office located in the Industrial Commission of Arizona Building, 800 W. Washington, 5thFloor, Phoenix, Arizona 85007.

Random Selection Criteria

- a. Applicants will be required to meet the qualifications of licensure before obtaining the license. *A.R.S. §4-202 and 203*
 - b. To meet license issuance requirements, a physical location for your licensed business must be established. *A.R.S. §4-203*
 - c. No person shall submit more applications than the number of licenses available for each series in a county. (See the list below)
 - d. No person shall submit more than one entry form per location per liquor license series.
 - e. If the number of applicants for entry into the drawing do not exceed the number of licenses in a series to be issued in that county, without using the random selection process, the department shall issue a number of licenses equal to the number of entries received.
 - f. An independent accounting firm will assign an ID number to each entry. These numbers will be mailed to applicants by the firm prior to the date of the random selection.
 - g. If applicable, alternate applicants will be drawn for each license series in each county. An alternate list of applicants will be maintained until all new licenses have been issued.
 - h. Alternates shall be eligible for consideration as licensees in the event a successful applicant chooses not to be considered or is disqualified. Such consideration shall be determined by the numerical order in which the alternates were drawn.
- IV. Random Selection Drawing. If there are more applicants than the number of licenses available, a random selection drawing will be conducted on Monday, June 2, 2014 at 10:00 a.m. in the auditorium of the Industrial Commission Building located at 800 W. Washington, Phoenix, Arizona 85007. The random selection process will be overseen by an independent accounting firm.
 - V. Names of the successful applicants and alternates will be posted within 24 hours of the lottery drawing on the Department of Liquor website (www.azliquor.gov) and office located in the Industrial Commission of Arizona Building, 800 W. Washington, 5thFloor, Phoenix, Arizona 85007.
 - VI. Upon completion of the Random Selection Drawing, the selected applicants will be notified by U.S. Mail. Upon receipt of a completed disclosed location application, the Department of Liquor will route the application to the appropriate local government for immediate posting at the proposed location and for processing. Upon disqualification or withdrawal of an application, an alternate will be notified by phone and U.S. Mail immediately. The completed application for the alternate will be distributed to the appropriate local government for posting and processing.
 - VII. A non-refundable deposit of fifty percent (50%) of the fair market value of the license shall be paid (certified funds only) to the Department of Liquor before 3:00 p.m. Monday, September 1, 2014. The balance of the fair market value will be due within (5) days after notification that the license is ready for issuance. Failure to submit payment will result in an automatic disqualification. In addition, an original license issuance fee as well as annual renewal and surcharge fees will be calculated and due at the time of issuance. Payment shall be made by personal check, money order or direct deposit. See schedule below for fair market values.

Final fee totals will include the Fair Market Value (FMV) of the license, the non-refundable application and fingerprint fees.
