BASIC - Classroom Title 4 Training Providers

Arizona liquor law does not require that all employees of a licensed establishment have a "Certificate of Completion" for BASIC Title 4 training. Some licensed locations may require this of their employees as a term/condition of employment, however. The BASIC Title 4 training "Certificate of Completion" will remain in effect for three (3) years from the completion date recorded on the certificate. Title 4 training providers are required to keep record of all class participant's Certificate of Completion on file for a minimum of two (2) years. Please contact your training provider for a replacement copy of your Certificate of Completion as this agency does not keep them on file.
