ACCEPTABLE FORMS OF IDENTIFICATION

A.R.S. §4-241. Selling or giving liquor to underage person; illegally obtaining liquor by underage person; violation; classification; definitions


- K. The following written instruments are the only acceptable types of identification:
1. An unexpired driver license issued by any state or Canada if the license includes a picture of the licensee.
 2. A nonoperating identification license issued pursuant to section 28-3165 or an equivalent form of identification license issued by any state or Canada if the license includes a picture of the person and the person's date of birth.
 3. An armed forces identification card.
 4. A valid unexpired passport or border crossing identification card THAT is issued by a government or A voter card THAT IS issued by the government of Mexico and IF THE PASSPORT OR CARD contains a photograph of the person and the person's date of birth.
 - Valid AZ Driver's License or AZ I.D. Card
 - Valid photo passport from any country
 - Valid photo Driver's License from any U.S. state
 - Valid photo Military I.D.
 - Valid Border Crossing Card (Mexico or Canada)
 - Valid Canadian photo Driver's License or ID Card
 - Valid Mexican Voter's ID Card




Out of State ID Card

▲ Mexican Voter ID Card





NECESSARY EQUIPMENT FOR CHECKING ID'S

Don't use ambient lighting

1. **Flashlight**
(cannot properly check ID without one)
2. **Black light UV**
(for security features)
3. **Magnifying glass**
(for security features)

Security Features of ID Cards

A.R.S. § 4-241.A.2: "A non-operating identification license issued pursuant to section 28-3165 or an equivalent form of identification license issued by any state or Canada if the license includes a picture of the person and the person's date of birth."

A.R.S. § 4-241.A.1: "An unexpired driver license issued by any state or Canada if the license includes a picture of the licensee."

Armed Forces Identification Card

A.R.S. § 4-241.K.3: "An armed forces identification card."

Passport from Any Country

Passport must be

- Unexpired
- Contain DOB & Picture
- Issued Within Last 15 Years

A.R.S. § 4-241.A.4: "an unexpired passport...which is issued by a government...which contains a photograph of the person and the person's date of birth."
