If your annual production is more than 20,000 gallons, a farm winery may only sell to Arizona wholesalers. An out of state farm winery may participate in wine festivals upon application, and approval, with the Arizona Department of Liquor. ARS 4-205.04 for all the laws pertaining to farm wineries in Arizona.
