15	Special Event	25.00 per day	<ul style="list-style-type: none"> <li>• A licensed special event may last a maximum of 10 consecutive days.</li> <li>• Events held on liquor-licensed premises do not require local government approval.</li> <li>• Events held on unlicensed property will require local government and state approval. Not more than 30 days per year may be held at an unlicensed location.</li> <li>• Government-owned locations that do not hold a liquor license may be issued unlimited special event licenses per calendar year.</li> <li>• Applications must be received by the Department of Liquor 10 days prior to the first day of the event.</li> <li>• May utilize an approved special event contractor.</li> </ul>
16	Fair/Festival	15.00 per day	<ul style="list-style-type: none"> <li>• Maximum 50 events per farm winery up to 150 days</li> <li>• Maximum 150 days per year for Craft Distiller</li> <li>• Fair requires a sanctioned county/state fair</li> <li>• Application requires approval from local government for farm wineries</li> <li>• Application may require approval from local government if not on an already licensed premise</li> </ul>
n/a	Sampling Event Sponsored by Producer or Wholesaler	n/a	<ul style="list-style-type: none"> <li>• A maximum of two 3-hour events per location per day</li> <li>• Producer or Wholesaler apply online using authorization code assigned by DLLC</li> <li>• Location must have 5,000 sq. ft. retail space or 75% of shelf space dedicated to the sale of liquor</li> <li>• Application must be received no less than 5-days prior</li> <li>• Sampling conducted by sponsor or sponsor rep</li> </ul>
